The Fund will send you a Form 1099-DIV for the calendar year that will tell you how to report these distributions for federal income tax purposes, or will provide your financial intermediary firm with the information necessary to produce and send you such Form 1099-DIV.

<sup>1</sup> Excludes the Fund's distribution of \$0.59267 per share, which was declared by the Fund on December 17, 2021 and paid on January 11, 2022 to shareholders of record as of December 28, 2021, consisting of long-term capital gains realized in the Fund's prior fiscal year ended December 31, 2021. For federal income tax purposes, that distribution will be treated as paid on December 31, 2021, as it was declared by the Fund in December 2021 with a record date in the same month, although the distribution was paid in January 2022.
